#### **Dual Status Youth Reform in Texas**

In January our Executive Director, John A. Tuell, presented on Dual Status Youth (DSY) Reform to the Texas Family Justice Conference just outside of Austin, Texas. This opportunity was made available through our partnership with the Texas Children's Commission (TCC). Following the Conference, John met with TCC's leadership to strategize on methods to deploy the DSY training and technical assistance to interested jurisdictions within Texas. The RFK National Resource Center is delighted to support the State's ongoing and committed interest in improving practice and policy on behalf of the DSY population.

#### **Expanding Probation System Reform**

We are looking forward to the launch of two new field-based technical assistance partnerships in Washington County, Minnesota (March 2018) and the state of Delaware (tentative April 2018) to conduct Probation System Reviews. In both new sites, leadership has demonstrated an interest in advancing their policies and practices in probation and their juvenile justice systems around the best available adolescent development science and evidence-based approaches and services.

#### Ongoing Work in Nebraska and Nevada

The RFK National Resource Center is preparing for returns to Lancaster County, Nebraska (Lincoln) and Clark County, Nevada (Las Vegas) in April 2018 to present the final report of findings and recommendations from the conduct of Probation System Reviews in each jurisdiction covering the period from May 2017 - March 2018. The leadership and staff among all probation and juvenile justice system stakeholders are to be congratulated for their active and open participation throughout the ongoing review.

### **Update from Our Practice Networks**

On January 8 and 9, 2018 representatives from the Milwaukee County Division of Youth and Family Services and the Wisconsin Department of Children and Families participated in a site visit to Jefferson Parish, Louisiana. Jefferson Parish was one of the first jurisdictions to participate in the Probation System Review process back in 2009. Milwaukee County's probation system review concluded in October 2017 and they are embarking on an 18-month process to implement the improvements recommended in the review.

Drawing from the insights and lessons learned from Jefferson Parish, Milwaukee County is better prepared to address critical improvements in their screening and intake process, benchmark best practices and performance measures, and make improvements in matching youth to the programs that best meet their needs. Milwaukee County appreciates the kindness and hospitality shown by the people of Jefferson Parish Department of Juvenile Services that made the trip so pleasant, memorable and productive.

This learning opportunity was spearheaded by members of the RFK National Resource Center **Practice Networks**. #### Now Available - New Brief Focused on Improving Education Services in Juvenile Justice Facilities

The National Reentry Resource Center, the CSG Justice Center, and the American Youth Policy Forum released a new policy brief today that provides state and local policymakers as well as education and juvenile justice leaders with information about how they can use requirements under the Every Student Succeeds Act (ESSA) to improve education and workforce outcomes for youth in long-term juvenile justice facilities. The brief, <u>Leveraging the Every Student Succeeds Act</u> to Improve Educational Services in Juvenile Justice Facilities:

- Summarizes relevant ESSA provisions and outlines its key accountability requirements;
- Highlights three priorities for states to focus on as they contemplate accountability for juvenile justice programs and schools;
- Provides key questions to help state and local leaders consider their current policies and identify gaps and opportunities for improvement; and
- Features states that are carrying out promising practices in each of the three priority areas, which can serve as examples for other states that are seeking to improve accountability for juvenile justice schools.
