## Symposium on the Future of Juvenile Community Supervision

With the support of the federal Office of Juvenile Justice and Delinquency Prevention (OJJDP), the Robert F. Kennedy National Resource Center for Juvenile Justice, the Council of State Governments (CSG) Justice Center, and American Probation and Parole Association (APPA) have partnered to host an unprecedented symposium at APPA's 43rd Annual Training Institute on the future of juvenile community supervision.

As juvenile incarceration rates have declined nationally by over 50 percent in the last decade, community supervision agencies are increasingly challenged to serve youth that have a higher risk of reoffending. Research shows that up to half of youth on probation and two-thirds of youth released from incarceration are re-arrested within two years. To address this challenge, the goals of the symposium are to: 1) review the current state of the field on implementing what research shows I working to improve outcomes for youth, and 2) propose a new vision for how juvenile community supervision agencies should operate and use limited resources most efficiently to enhance public safety and improve outcomes for youth. National experts will join staff from the CSG Justice Center and RFK National Resource Center to host three workshops to describe the key components of this new vision, and leading jurisdictions will highlight strategies that they have employed to transform their policies and practices. The three sessions will take place on Monday, July 30 and include:

- Envisioning the Future of Juvenile Community Supervision
- The Future of Juvenile Community Supervision: Supervision Conditions, Monitoring, and Accountability
- The Future of Juvenile Community Supervision: Probation and Parole Officers as Agents of Positive Youth Behavior Change



State Governments (CSG) in the implementation of the Second Chance Act Community Supervision grant program. With support from the Office of Juvenile Justice and Delinquency Prevention (OJJDP), the Probation Departments of Cook County, Illinois and Cobb County, Georgia will be receiving a comprehensive Probation System Review with the goals of reducing recidivism and improving other outcomes for youth that come in contact with their juvenile justice systems. Over the course of the next 12 months, both Cook and Cobb Counties will undertake this intensive assessment of probation system functioning and performance to develop an action plan to implement policy, practice and funding changes. We look forward to working closely with CSG to support these two counties in their reform efforts while expanding and broadening the Probation System Review process.

# Probation System Review Launched in Washington County, Minnesota

Update Provided by our Executive Director, John A. Tuell The RFK National Resource Center for Juvenile Justice concluded its initial technical assistance site visit on March 1-2 in Washington County, Minnesota as we launched our partnership to conduct a Probation System Review. We encountered an impressive array of passionate and experienced juvenile justice system stakeholders from multiple disciplines. The consulting team (Kari Harp, Probation System Reform Program Director and I) began the two days by speaking with nearly 40 key stakeholders that included Minnesota Community Corrections leaders and probation staff, judges, county attorney, law enforcement, school administrators, and child welfare, behavioral health and community service providers to outline the Probation System Review process. We then began our interviews and analysis in greater depth by meeting with individual groups within the juvenile justice system, and facilitating in-depth discussions about policies, practices, strengths and challenges with a terrific group of probation staff. We left the site invigorated by the belief that there is a courageous willingness by everyone to examine how to improve youth outcomes and system performance. We are grateful for the opportunity to partner with Washington County in this important review and look forward to continuing our collaborative work for the remainder of 2018.
