CONNECT Act Reintroduced

Bipartisan Bill Addresses the Needs of Dual Status Youth

On May 14, U.S. Senators Gary Peters (D-Michigan) and Chuck Grassley (R-Iowa) reintroduced bipartisan legislation known as the CONNECT (Childhood Outcomes Need New Efficient Community Teams) Act. This important legislation (S.1465) will assist states in addressing the unique challenges of youth who are involved with both the juvenile justice and child welfare systems, known as dual status youth. The RFK National Resource Center is proud to have assisted with the development of the CONNECT Act and applauds the diligence of Senators Peters and Grassley in working to ensure its passage.

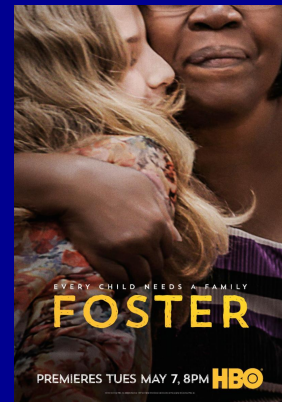
Ivy Tillman Joins Our Team of Expert Consultants!

With one in eight American children suffering a confirmed case of neglect or abuse by age 18, there are currently more than 400,000 children in foster care in the U.S., a number that continues to grow each year. Advancing Best Practices Training Seminar Delivered for the Judiciary of Guam

This month, Executive Director John A. Tuell provided two days of judicial training, primarily using the Advancing Best Practices in Youth Justice Seminar curriculum, at the request of the Judiciary of Guam. Held in Hagatna, Guam, the session was open to critical juvenile justice stakeholders (i.e., attorney general, public defense, probation, community providers, and education) and attended by over 30 participants. The dynamic training featured segments on adolescent development, trauma, use of risks-needs-responsivity instruments, alternative responses to formal prosecution, positive youth development, graduated responses, dual status youth and implementation science. The judicial training launched a renewed partnership with Guam to continue their advance toward the positive transformation of their juvenile justice system.

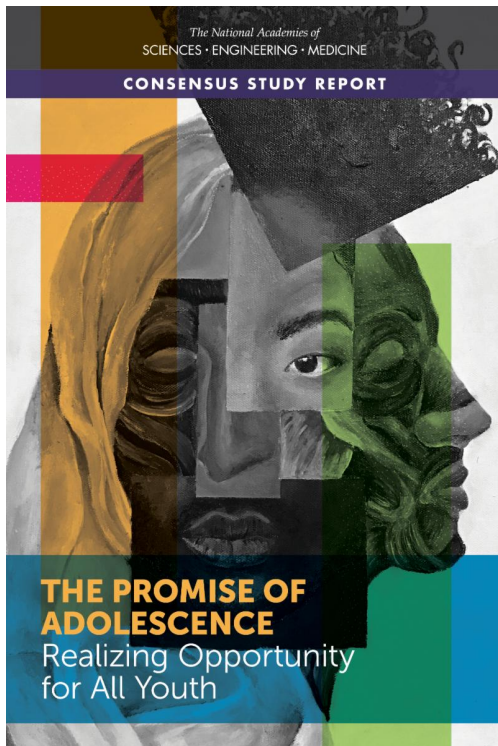

The Promise of Adolescence: Realizing Opportunity for All Youth



Adolescence - beginning with the onset of puberty and ending in the mid-20s - is a critical period of development during which key areas of the brain mature and develop. These changes in brain structure, function, and connectivity mark adolescence as a period of opportunity to discover new vistas, to form relationships with peers and adults, and to explore one's developing identity. It is also a period of resilience that can ameliorate childhood setbacks and set the stage for a thriving trajectory over the life course. Because adolescents comprise nearly one-fourth of the entire U.S. population, the nation

needs policies and practices that will better leverage these developmental opportunities to harness the promise of adolescence, rather than focusing myopically on containing its risks. [This report](#), released by the National Academies of Sciences, Engineering, and Medicine, examines the neurobiological and socio-behavioral science of adolescent development and outlines how this knowledge can be applied, both to promote adolescent well-being, resilience, and development, and to rectify structural barriers and inequalities in opportunity, enabling all adolescents to flourish.

Stages of Implementation Analysis: Where Are We?

"Implementation Science is the study of factors that influence the full and effective use of innovations in practice. The goal is not to answer factual questions about what is, but rather to determine what is required." All implementation stage assessments are now merged into one tool. This planning resource provides an implementation team in a state or local jurisdiction the opportunity to assess, plan and track stage-based activities and improve the success of implementation efforts, evidence based programs, and approaches across all stages of juvenile justice and probation system transformation efforts. The National Implementation Research Network (accessible at: <https://nirn.fpg.unc.edu/>) provides excellent guidance and publication resources to support the use of Implementation Science in transformational reforms for state and local jurisdictions engaged in juvenile justice and probation practice improvements.
