Call for Workshop Proposals

Transformation of Youth Justice Symposium: *Expanding Knowledge, Changing Practice, Achieving Outcomes* March 24-25, 2021 | Nashville, Tennessee

The RFK National Resource Center is pleased to invite practitioners, leaders, and experts from across the country to submit workshop proposals for the March 2021 <u>Transformation of Youth Justice Symposium</u>. The RFK National Resource Center is accepting proposals focused on practical, effective, and innovative reform efforts that transform youth justice and improve outcomes for children and families.

Workshop and Presenter Criteria

The RFK National Resource Center is accepting proposals for workshops that will showcase reform efforts and practices that effectively impact the transformation of youth justice, resulting in improved outcomes for children and families. All workshops must feature methods and guidance for replication of the program or practice reform and incorporate participant engagement (e.g., interactive discussion, breakout groups, peer-to-peer learning activities). All workshop sessions will be a maximum of 90 minutes.

The RFK National Resource Center emphasizes the importance of peer- to-peer learning and diversity. We especially encourage workshops to be presented by individuals with on-the-ground experience, diverse backgrounds, and/or who are reflective of the constituencies they serve. We invite the submission of workshop proposals on all critical issues impacting juvenile justice reform and youth justice transformation, but will give preference to workshops focused on a variety of topics identified on our <u>Call for Workshop Proposals</u> webpage, including:

Clark County, Ohio Launches a New Dually Involved Youth Initiative

On September 24 & 25, Clark County's multi-agency and community partnership facilitated a full-day training for over 150 participants to launch the new Dually Involved Youth Initiative. Through the inspired leadership of Judge Katrina Lancaster and Virginia Martycz, Director of Job and Family Services, and many other dedicated professional stakeholders, this training event highlighted the new policies, practices, procedures, and measurement methods developed over the past year through the technical assistance support of the RFK National Resource Center -- made possible by a scholarship awarded by the Ohio Supreme Court. The initiative features:

- early and consistent identification of their target population of dually involved youth;
- early intervention to stabilize placement, family situation and exploration of alternative responses to formal prosecution;
- multi-agency teaming at key decision points;
- expedient access to more precisely identified treatment and service interventions;
- coordinated cross-system case management; and,
- an exemplary method for measurement and reporting of outcomes.

Their work has already been instructional in ongoing dual status youth initiatives in Delaware, Idaho, Pennsylvania, and California. Congratulations to Clark County! We look forward to continuing our partnership with you to support implementation over the next twelve months.

From the Field

New Urban Institute Brief on Juvenile Diversion in Kentucky

The Urban Institute has <u>released a new brief</u> assessing Senate Bill 200 juvenile diversion reforms in Kentucky. Urban examined the state's juvenile diversion program to see how reforms impacted case decision making and outcomes for youth entering intake on less serious offenses. The research presented in *Assessing Juvenile Diversion Reforms in Kentucky* shows not only that more youth were diverted from formal court involvement after reform, but also that Kentucky maintained its high diversion success rates (nearly 9 out of 10 youth completed diversion) and had no statistically significant change in recidivism in any eligible complaint category. Urban observed increases in diversion for all youth - that is, for boys and girls, white youth and youth of color, and youth charged with a wide range of complaints. Though racial and ethnic disparities are significant and persistent, particularly for Black youth, Urban found that policy reforms began to narrow the gap between White and Black youth in some cases.

New Report on the Impact of Juvenile Justice Involvement on School Attendance

The Council of State Governments (CSG) Justice Center released a new report that summarizes key findings from an unprecedented research study on the impact of juvenile justice system involvement - particularly probation - on school attendance in South Carolina and challenges jurisdictions across the country to reconsider whether system involvement is the most appropriate and effective way to promote youth's school success. Rethinking the Role of the Juvenile Justice System: Improving Youth's School Attendance and Educational Outcomes reveals that kids involved in the juvenile justice system in South Carolina not only didn't experience school attendance improvements, but their attendance actually got worse. The CSG Justice Center study also raises concerns about whether some schools' policies and practices make it harder for justice-involved youth to engage and succeed in school. This new research compels policymakers, judges, attorneys, probation directors, and educators to wrestle with an important question: are juvenile justice system involvement and school disciplinary measures really the most appropriate and effective ways to help kids succeed in school?

The report is accompanied by a set of infographics on <u>truancy</u> and <u>juvenile</u> <u>probation's role in youth's education</u> that include concrete policy and practice recommendations for jurisdictions to consider.
