

**2012 Probation Department Paradigm** *shift*

**2012** Juvenile Detention Alternative Initiative returned (previously entered in the 90's)

2012-13 Youth Assessment Screening Instrument (YASI) Implemented

2013 Juvenile Justice Reform & Reinvestment Initiative (JJRRI) Initiated

2015 current Detention Risk Assessment Instrument (DRAI) Implemented

2016 Juvenile Program Management (JPM) Data System Launched

2017 RFK Probation System Review Initiated

2018 current Youth Assessment Team Created


### POLICY AND DATA ALIGNMENT

#### Process Measures (Monthly)

- 1. Intakes Processed
  - Detentions (DT)
  - Non-Detentions (Order Ins)
- 2. Detention Intakes transferred to our Ongoing Team(s) within 6 Days of the receipt of Police Referral
- 3. Non-Detention Intakes submitted to the District Attorney's Office within 30 Days of the Receipt of Police Referral
- 4. HSW Caseload Sizes
- 5. Case Transferred
  - To OnGoing (Moderate & High Risk)
  - To Diversion Alternative Team (Low Risk)

#### Youth Outcome Measures (Quarterly)

- 1. HSW Recommendation
- 2. District Attorney Decision
- 3. Prevalence of Trauma\*
- 4. Recidivism for Closures (First Referral)
- 5. Cases Deferred
- 6. Cases Closed










