Growth-Focused Case Management and RFK National Resource Center: A New Partnership

We are excited to announce our exclusive partnership with Jonathan Cloud, creator and author of the Growth-Focused Case Management (GFCM) approach and practice. This new partnership will enhance and strengthen our training, technical assistance, and consultation outreach and expand the innovative GFCM framework and approach to positively impact more youth and families across the country.



The GFCM approach prioritizes Risk-Needs-Responsivity and Positive Youth Development in a complementary manner that protects community safety and fosters positive identity. The purpose of GFCM is to develop and manage case plans with youth that facilitates forming a positive identity with which offending is no longer compatible.

We are in the process of developing a GFCM workbook which will be made available in our [Online Resource Library](#) in early 2022. The workbook will provide supporting research, tools, and a step-by-step process for implementing a GFCM approach.

Implementation of GFCM is currently underway in Milwaukee County (Wisconsin), Clark County (Nevada), Washoe County (Nevada), Hancock County (Ohio), and Hennepin County (Minnesota), and will feature a two-day training for case managers and probation personnel in North Dakota in April 2022. On the Ground

Ohio: Forensic Training

In November, the Ohio Mental Health and Addiction Services Department of Forensic Services held their annual professional education conference, focusing on the changes in the Ohio statute language for competency restoration, and the populations that this will most likely impact. RFK National Resource Center's Executive Director John Tuell presented a session titled "Dual Status Youth: Innovative Solutions and Positive Outcomes" highlighting the approach, the practice, and the innovative solutions and positive results from our partnership with more than 30 state and local jurisdictions, highlighting the current reform in six counties in the state of Ohio. The session included a discussion of case law and a roadmap for jurisdictions to achieve the same positive results.

Clark County, Nevada: Dual Status Youth & Commercially Sexually Exploited Youth Technical Assistance (TA) Initiative

With plans to begin in early 2022, this two-year initiative will focus primarily on dual status youth reform with a special emphasis on the development of multi-system policies, practices, and institutionalized system coordination to positively impact the sexually exploited and human trafficked youth in Clark County, Nevada. RFK National Resource Center will use the Dual Status Youth TA Workbook (2021 Updated Edition) to guide the activities. The project will include the expertise of Dr. Robin Jenkins and his colleagues from the Frank Porter Graham Impact Center at the University of North Carolina, Hunter Hurst from the National Center for Juvenile Justice, and the University of San Diego Law School's Children's Advocacy Institute (CAI). This project builds upon the RFK National Resource Center's body of work in this area of focus that includes statewide projects ongoing in Delaware and Illinois.

Washington County, Minnesota: Probation System Review Implementation Project

In a continuing effort to enhance policy, practice, and service provision for youth and families, we are pleased to partner with Washington County on the implementation of two key recommendations from their 2018 probation system review. After the review, leadership created an intake unit which has allowed them to significantly reduce the number of low-risk youth entering formal probation supervision. With this endeavor firmly in place, Washington County leadership is working with relevant stakeholders to integrate a new risk-screening process at the prosecutorial decision point. They are also renewing their effort to examine their data collection and data management to identify key benchmarks. This commitment toward integrating these practices will allow them to serve youth at the earliest possible decision point in a manner consistent with a youth's risk, and to establish regular review criteria supported by local data to assure the process is producing results that are in the best interest of the youth served.
